





••• What are Frameworks?

- An agreement put in place following a full European Union (OJEU) compliant competitive tender process with a provider or range of providers that enables buyers to place orders for services without running lengthy full tendering exercises.
- Widely used across the public sector
- Good for services that you can define and have demonstrated that considerable time and cost savings can be made.
- Based on large volume purchasing. Aggregating different purchasers' potential needs means individual purchasers can buy goods and services at prices below those normally charged, or with special added benefits and/or more advantageous conditions.

• • National LGPS Frameworks

- Hosted by Norfolk Pension Fund (Norfolk County Council) on behalf of LGPS from 2012
- Recognising we all have to buy support services and we all have to comply with Public Contracts Regulations, so;
 - National LGPS Frameworks are an OJEU compliant procurement vehicle
 - They remove the need to independently undertake full European Union (OJEU) procurement – shortened procurement timescales
 - Retain local service definition and decision making
 - Leverage our combined buying power

- Sharing knowledge and information
- Extracting added value from providers
- Ensure access to good quality services
- Supported by a wide range of Framework Procurement and Legal specialists and LGPS expertise - the 'Founders'

• • • National LGPS Frameworks Key benefits for users

Lower prices and shortened timescales, but also...

- Agreed Terms and Conditions of contract
- Comprehensive user documentation
- Easier for the LGPS to access wider range of service providers
- Cumulative rebates over £287,000



• • • National LGPS Frameworks Key benefits for providers

- Agreed Terms and Conditions of contract
- Standard consistent process with standard tender documents provided to funds
- Shortened timescale for Procurement = new business known quicker
- Encouragement from central Government to use the frameworks.
- Managed framework continuity
- Easier for Funds and Pools to access and know about providers



Scope – who can use the National LGPS Frameworks?

- LGPS Administering Authorities (England, Scotland, Wales and Northern Ireland) and participating employers (and pools)
- Use by wider public sector bodies but primarily focused on the LGPS



• • • • So – where are the National LGPS Frameworks now?

- o 7 active Frameworks
- 2 expired Frameworks (but with contracts still running under them)
- 2 more in development (and considering more)
- 200+ joiner agreements across 86 different user organisations (including 84 LGPS funds)




• • • So – where are the National LGPS Frameworks now?

- Real, practical help e.g. contracted-out reconciliation
- Not just high-value, OJEU works
- LGPS-wide solutions e.g. investment management cost monitoring and reporting
- Positive feedback from users and providers
- Continued demand for wider coverage
- Estimated £88m in procurement and service cost savings

• Legal Services

- Framework expires 12 Jan 2019
- Re-let to be confirmed by Founders (to incorporate future LGPS requirements)

• General Data Protection Regulation (GDPR)

- applies in the UK from 25 May 2018
- impact assessment
- project to ensure contracts remain in line with statutory requirements
- Member Data Verification (including Mortality Screening, Address Tracing)
 - This would be a new Framework
 - Founders are being confirmed
- AVC Provider review
 - proposal to Founders
